1 I am the defendant in these proceedings.

Background of AVN and Stop AVN

2 Meryl Dorey is the founder and president of Australian Vaccination Network Inc ("AVN").

3 AVN is an anti-immunisation lobby group. Annexed to this statement and marked "A" is a screencap of the "About the AVN" page on the AVN website which I obtained.

4 A major activity of AVN is publishing and publicising anti-immunisation information. They are very vocal on the internet and in the media. They hold public seminars. I am aware that Meryl Dorey has spoken on public radio and on television in relation to immunisation issues.

5 Stop AVN is a Facebook group that was established to address the incorrect claims of AVN. It currently has over 4,500 members.

6 Stop AVN aims to expose the incorrect information spread by AVN about immunisation. Its members do this by closely monitoring the claims by AVN and then publishing information which debunks those claims. They also look for any breaches by AVN of the health legislation, and where a breach is identified make complaints to the appropriate authorities. As a result of investigations following these complaints the AVN has been investigated by the Health Care Complaints Commission, lost their charitable fundraising license and has received plenty of negative media coverage.

My involvement

7 I became aware of Stop AVN in the first half of 2010 when a friend showed me the Facebook group. I joined the Facebook group shortly after I became aware of the group. I do not have any leadership or organisational role in Stop AVN.

8 Since joining the Stop AVN Facebook group I have been active in countering the misinformation which AVN spreads about immunisation. My goal is to hold the AVN

to account for the incorrect medical advice that it dispenses in order to push its anti-vaccination ideology.

- 9 I have made a complaint to the Department of Fair Trading about AVN creating a website called "The REAL Australian Sceptics" which I believe was an attempt to mimic Australian Skeptics Inc with the intent of misleading the public by using a confusingly similar name. Annexed to this statement and marked with the letter "B" is a copy of my complaint.
- 10 I have made many blog posts on my blog about AVN. I have posted comments about AVN and immunisation on Stop AVN's Facebook page, on my Twitter account and on relevant forums. I have also posted comments on the AVN website and Ms Dorey's blog in response to blogs that she has written about Stop AVN and immunisation.
- 11 The comments that I have posted are always in response to something that AVN or Ms Dorey has said or done. All of my posts have been about the immunisation issue and the activities of AVN. My goal is to get the other side of the argument heard and get a bigger audience for the vaccination issue (more people realising that it is an issue).
- 12 Whenever I have mentioned Ms Dorey it has been in the context of her activities with AVN.
- 13 I have never threatened Ms Dorey or any member of AVN.

The "goatse" post

- 14 I did post a Tweet on 2 September stating "*so the place to mail goatse images is to PO Box 177 BANGALOW NSW 2479 AUSTRALIA, Right? #stopavn*". That Tweet was made in the context of a discussion on Stop AVN about a section that was published on AVN's website at about that time.
- 15 For approximately 2 years Meryl Dorey and the AVN have accused members of Stop AVN of sending her pornography. I often saw her bring up this accusation. I am not aware of any member of Stop AVN sending pornography to Ms Dorey. This has been discussed on Stop AVN on numerous occasions and there is some doubt about the legitimacy of these claims. I personally do not believe these claims.
- 16 At the end of August I became aware that a section had been added to the AVN website titled "Dossier of Attacks on AVN" (the "Dossier"). One page on that part of the website was about pornography which they say has been sent to them by

people associated with Stop AVN. Annexed to this statement and marked "C" is a copy of that page.

- 17 Many people in Stop AVN were having online conversations about the Dossier. Most people did not take the Dossier seriously because Ms Dorey frequently accuses her critics of "attacking" and "harassing" her whenever they try and hold her to account for her false and misleading claims.
- 18 When I posted my Tweet on 2 September it was a tongue in cheek reference to the conversations that I had with other members of Stop AVN about the claims (which I thought were baseless) that members of Stop AVN had sent her pornography. I do not believe that anyone from Stop AVN has ever sent pornographic material to Ms Dorey or the AVN.
- 19 I did not intend for anyone to actually send goatse images to the address. I believed that in the context of our conversations about the Dossier that the members of Stop AVN would understand that this Tweet was a joke.
- 20 The address in my Tweet is the contact address posted on the AVN website. Annexed to this statement and marked with the letter "C" is a copy of the contact us page on the AVN website.
- 21 I have never sent any pornography to AVN or Meryl Dorey.
- 22 Goatse was a shock site that existed in the 90s at: <http://www.goatse.cx> A common prank back then was to try and trick other computer users into visiting the site.

The response to Ms Dorey's blog post

- 23 I did write the response to Ms Dorey's blog post (as quoted in paragraph 7 of Ms Dorey's statement "*This is indeed a human issue...So that communities can know if anti-vaxxers are living nearby.*").
- 24 When I said that AVN needs to be attacked and brought down in any way possible I meant by the legal steps that I had been taking of monitoring their actions, reporting breaches to government authorities, and publishing information against the false information that AVN posts. AVN has defined such lawful activities as "attacks" in the Dossier, so in this context I felt that use of such wording was in line with Ms Dorey's phraseology regarding the activities of her critics.
- 25 I said that "perhaps there needs to be a national anti-vaxxer register" because in my view not being immunised poses a health risk to the community and people should know if there are unimmunised people near them.

Tweets to @nocompulsoryvac

- 26 In paragraph 11 of her statement Ms Dorey quotes several Tweets.
- 27 My Twitter name is DanBuzzard.
- 28 On Twitter it is possible to share content that's been posted by another user. The Tweets with the letters "RT @ drunkenmadman" are examples of where I have Retweeted something that another person has said.
- 29 When I said I would love to see her be busted under US laws I was referring to what I believe is an act of perjury committed by Ms Dorey under the jurisdiction of the United States of America. In April 2011 Ms Dorey asserted a false claim of copyright under the (US) Digital Millennium Copyright Act by swearing under penalty of perjury that she was the exclusive rights holder to a NSW Government document. I believe Ms Dorey's misuse of the copyright law constitutes a Felony under US Jurisdiction, which she consented to in her notice.

The Why We Protest forum

- 30 Why We Protest is an anti-scientology website. Part of the website is a forum.
- 31 I became a member of Why We Protest in 2008. I have posted on the website a total of 5 times. I do not visit the website often.
- 32 In 2008 I made 4 posts about scientology.
- 33 In 2012 I saw an anti immunisation comment posted on Twitter which linked to a discussion on the Why We Protest forum. I followed that link and noticed that I was already a member of the forum. I made one post in response to the post which was about vaccine injury. Annexed to this statement and marked "D" is a copy of the post. I then posted a link to the thread on Twitter and Facebook.
- 34 The reason that I posted on Twitter about being a member of Why We Protest since 2008 was because the person who posted the original link to Why We Protest posted a comment on Twitter accusing me of following her to the site. I simply pointed out that my account was from 2008.

Anonymous and hacking

- 35 I am not a hacker.
- 36 I have no links to the Anonymous hacking group. I am actually anti-anonymous and have spoken against them on my blog several times in the past.
- 37 I did receive an email from someone claiming to be from the Anonymous hacking group on the 25th of September.

- 38 I do not know who fantasticfox5@tormail.org is. I do not know why fantasticfox5 decided to send an email to me. I don't know how fantasticfox5 found my email address, however I have posted my email address as a contact on some of my posts about AVN. I never incited or encouraged that person to send that email or post pornographic images on AVN's Facebook Page.
- 39 On the 25th of September I posted a comment on the AVN facebook site providing a copy of the email I received to the AVN along with the email headers that might allow their private investigator, or law enforcement to track down the original sender. Annexed to this statement and marked "E" is a copy of the email and the linked documents.
- 40 Since its inception Stop the AVN has never endorsed any vigilante or other illegal activities, nor have I. All of our actions against the AVN take place within the boundaries of the law. Meryl Dorey has previously acknowledged this by stating *"The Skeptics have worked out a way to rot the system by using current legislation to victimise those who they disagree with."* (28 April 2012). Annexed to this statement and marked with the letter "F" is a copy of Ms Dorey's post.
- 41 The AVN is a well-publicised organisation that's been publically criticised by national media on numerous occasions. There are many avenues that would allow members of the public to learn of this organisation's activities and Ms Dorey is constantly trying to gain media attention for herself and her organisation.

The Butthurt Report Form

- 42 I did not post the Butthurt Report Form on Why We Protest. I am not the user called "anonymous" who posted that form.
- 43 I saw the Butthurt Report Form post on Why We Protest. I had never seen it prior to this.
- 44 On about the 31st August I did post a copy of the Butthurt Report Form to PO Box 177 Bangalow NSW 2479. This was sent as a joke in response to a publication on the AVN's website called *"Dossier of Attacks on the AVN"* where Ms Dorey complains about me reporting her to the NSW Department of Fair Trading in May for failing to comply with regulations. Annexed to this statement and marked "G" is a copy of the page that page on the AVN website.
- 45 All my correspondence with Ms Dorey has always been to the AVN's official contact address' never her personal postal address or email. My correspondence has always included my correct name and return address, to allow right of reply. At no point prior to her AVO application has Ms Dorey ever requested that I do not

contact her. If I were to receive a request to cease communication I would have no problem honouring that request.

Posting about the AVO application on my blog

- 46 Prior to the 25th of September there was a lot of speculation about whether or not I would ever receive any summons for the court mention due on the 27th of September. The summons eventually arrived at approximately 11am on the 25th of September, I was given less than 48 hours between summons and court date for a location more than 4,000 Kilometres away.
- 47 The address on the summons was incorrect. I believe this may have delayed the Police in delivering the summons to my correct address more than 40km away from the address supplied by Ms Dorey.
- 48 I did mention this late arrival on my blog, but I did not disclose any contents of the claims she made in her application. Annexed to this statement and marked with the letter "H" is a copy of that blog post.

Comments made by AVN and Ms Dorey about me

- 49 Annexed to this statement and marked "I" is a copy of a page in the AVN "Dossier of Attacks" specifically about me.
- 50 Annexed to this statement and marked "J" is a response by Ms Dorey to a comment that I made on her blog. These comments refer to my attendance at a seminar that she hosted at the State Library in Perth in 2010 which I attended. A friend and I took notes throughout the seminar. We made no attempts to disrupt the seminar. To my knowledge this is the only time we have ever been in the same building.
- 51 Ms Dorey and the AVN have been publicising her AVO application through the organisations official channels and known associates. Annexed to this statement and marked "J" is a copy of those publications.

Other comments published by AVN and Ms Dorey about immunisation

- 52 Annexed to this statement and marked "K" are a number of screen caps of post made on the AVN facebook page.

About The AVN



The AVN was started in 1994 by a group of parents and health professionals who were concerned about the lack of scientifically-based information on the 'other side' of the vaccination issue.

We felt that the government and the medical community, in general, tended to exaggerate the safety and benefit profiles of vaccinations whilst downplaying their risks and true effectiveness.

For that reason, our group was formed with the express purpose of:

- providing medically-reference information on vaccine safety and effectiveness;
- lobbying to ensure that vaccinations are never made compulsory for Australian children; and
- supporting those who have chosen not to vaccinate or to vaccinate selectively.

From the beginning, we have operated as a volunteer-run community organisation. Until recently, we were a membership and donation driven group whose only sources of funding

were provided by our membership and sales of books, videos and DVDs in our web shop.

In 2009 however, an organisation was set up with the goal of forcing our organisation to close down. This group has filed dozens of complaints against us with various government departments and media outlets. They do not believe that freedom of speech or communication should be protected in Australia and want to close down the debate on this issue.

As a result of one of these complaints, the NSW Health Care Complaints Commission (HCCC) issued a public warning against the AVN. We fought against this warning and recently won our case in the NSW Supreme Court on the 24th of February, 2012. The HCCC has been ordered to pay our costs and have removed the warning. The Supreme Court stated that both the investigation and the warning were Ultra Vires (beyond their power) and their conduct of this investigation was illegal.

One of the outcomes of the Issuing of the HCCC's warning was the loss of our authority to be a charity – a status we had held from 1996 onwards. We are hopeful that this status will be reinstated prior to the end of April, 2012 at which time, we will again be able to accept memberships and donations from the general public.

Despite the requirement under Section 41 of the ASSOCIATIONS INCORPORATION ACT 2009 (NSW) which states "An association must not issue any letter, statement, invoice, notice, publication, order for goods or services or receipt in connection with its activities unless the association's name appears in legible characters on the document." The Australian Vaccination Network Inc has not included their name anywhere on the publication at <http://australiansceptics.com>. This publication is being promoted on their official Facebook and Twitter accounts, and the domain name australiansceptics.com is registered to "Australian Vaccination Network" there is no doubt that this publication belongs to them.

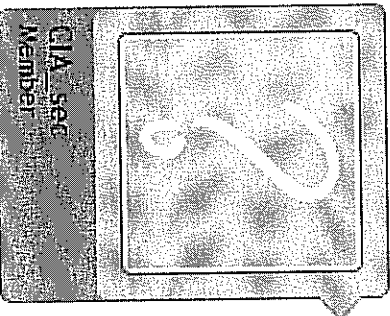

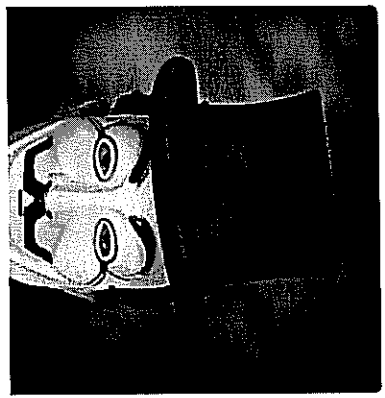

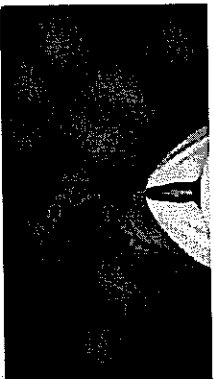

Please note – there is an action alert at the end of this posting.

Since being vindicated by the NSW Supreme Court on the 24th of February and subsequently having our authority to fundraise reinstated on the 18th of April this year, the AVN has been the subject of no less than four separate government investigations.

1- The Health Care Complaints Commission received a 90-page complaint by Ken McLeod – member of Stop the AVN and a man whose obsession with me seems to border on the psychotic. McLeod filed the original complaint, resulting in a 12-month investigation by the HCCC and a public warning – both of which were later deemed to be illegal by the NSW Supreme Court. It appears that McLeod must spend hours every day trying to prove that I am a liar and that the AVN is responsible for global warming, the current financial crisis and the death of every child from infectious disease no matter where in the world it occurs (this is only slightly tongue in cheek). I will be uploading McLeod's full complaint and the HCCC's response next week – I am just waiting to receive the last 67 pages which were sent to me by post. To their credit, the HCCC told McLeod that they had no jurisdiction to investigate either myself or the AVN (we were both named as respondents in the paperwork) based upon his evidence – some of which was gleaned by searching the archives of our email discussion list going back as far as 1998!

Despite the HCCC's rejection, it is obvious that McLeod will continue to try and get me charged with some sort of crime and will not stop trying to shut down the AVN until one of us is imprisoned or he is finally provided with the psychiatric support he seemingly needs.

2- The Department of Fair Trading which originally investigated the AVN back in 2009 due to

another complaint from McLeod and others involved with the Australian Skeptics and Stop the AMN, has come back again due to yet another complaint. Involving what appears to be dubious technicalities.

(a) Our old website did not include the name Australian Vaccination Network, Inc. It said Australian Vaccination Network and underneath that, the words "AVN, Inc." appeared. Apparently, because the name of the organisation is legally Australian Vaccination Network, Inc. the word "Inc." or "Incorporated" must appear on the banner of the page -- a requirement we were unaware of. In researching this issue, I did a random search of 15 other incorporated associations in NSW and out of that 15 (some of which are very large and well-funded organisations), 14 of them did not include either "Inc." or "Incorporated" in their banner or even on their home page! When I brought this to the attention of the investigating officer at the Dept of Fair Trading, I was told that no organisation had previously been cited for this reason and they only cite groups when this lapse is brought to their attention. Thanks Ken -- aren't we special?

(b) The department wants us to provide them with a breakdown of product sales we have made to members as opposed to sales to non-members because they seem to feel that we don't deserve to be registered as an incorporated association and instead, should be classed as a commercial enterprise. If we are a commercial enterprise, we need to go and write a better business plan because its only donations and memberships that have kept us afloat since our inception! In any case, the information they are asking for is not information we are required to keep track of and this has been confirmed by the Office of Liquor, Gaming and Racing -- the government department that administers charities and their requirements.

I have informed the Dept of Fair trading that I cannot break down our income from sales of products to members and non-members because we are not required to keep track of this and therefore, we have not done so. This doesn't seem to be satisfactory to them and they are continuing to ask me to provide them with this information or they may have to consider their 'options' in regards to our registration.

3- The Office of Liquor, Gaming and Racing (OLGR) which on the 18th of April reinstated our

authority to fundraise without any extra conditions since there was never any valid reason to revoke it in the first place (the sole reason was the illegal warning published by the HCCC), has stated *(please see the information at the end of this article on Dr-Andrew McDonald, Shadow Minister for Health in NSW and Mr George Souris, Minister for Gaming and Racing)* that we will be watched very closely and that it will only be a matter of time – sooner rather than later – that we will again be subject to another audit. I have no problem with this because any errors or technical breaches that were found in the OLGR's last audit have been corrected, but honestly, when there are organisations out there suspected of committing fraud, why is so much attention being paid to our small, volunteer-run group? The only reason is that SAVN and the Australian Skeptics continue to file vexatious complaints on an almost daily basis and the government, by their own requirements, are forced to investigate these complaints.

4- Earlier in the week, I received a call from a representative of the Therapeutic Goods Administration's (TGA) Advertising Codes Council who informed me that they had received a complaint about us (gee, I wonder who would have made such a complaint? I just can't imagine) and I would be hearing from them in the next few days in regards to a matter I will have to respond to.

I don't know at this point what the complaint is about, but having several friends in the natural therapies field who have received correspondence from this same department, I think I can guess.

Suppression of information and trade

It'd like to share with you what is going on with natural therapies in Australia. To put things into context, please remember that between 18,000 and 54,000 Australians are dying every year as a result of adverse reactions to properly prescribed medications [1] and medical error while there are virtually NO deaths from natural therapies which 60% of Australians use on a regular basis. Despite this evidence of safety, the government seems to spend an inordinate amount of time investigating natural therapists and – for all intents and purposes – almost no time investigating the medical profession.

Even when they finally DO investigate something – such as the recent case of doctors negligently giving infants and children a banned flu vaccine, leading to at least one child being placed in intensive care, the government stated that no doctor would be held responsible.

Is it just me or does this smack of a serious double standard?

The friends I know who have been contacted by the TGA's Advertising Codes Council have been ordered to remove information from their websites.

Why? Because the TGA has the power to treat *information* as though it were *advertising*.

How can this be? Basically, if you inform someone of something that touches on health and that might be capable of convincing the reader to take a certain course of action – which might involve buying something at some point somewhere from someone in the future – it's advertising. Even if the people providing the information weren't selling anything relating to that information – or linking or referring to anyone who may have been selling it (which they can also rule against) the TGA considers it to be advertising and can order it to be removed from the internet.

I have another friend who was selling a product which stated that it was 'paraben-free'. The product linked through to an unrelated website in the USA where there were scientific studies listing the potential problems caused by paraben exposure. The TGA, responding to a complaint from a pharmaceutical company which sold a competing product that just happened to contain paraben, came in and told this person that she had to remove the words 'paraben-free' from her website, change the packaging of her product and remove the links between her website and the website in the US. The thought police strike again! Not only are we not allowed to give out information on health issues – we aren't allowed to link to other people who are giving out information on health issues – even if those other people are outside of Australia.

You can't blame the TGA completely however, they are stuck between a rock and a hard place because once a complaint has been filed, they are required to investigate it. They probably don't like doing it any more than the person or business being investigated – but they have no choice.

The real villains here are those members of the Australian Sceptics and Stop the AVN who – though they themselves have not been harmed by any of these products, by any of this information or by any of these remedies – intentionally waste the public's time, money and expertise by pursuing vexatious and absolutely ridiculous complaints. The Sceptics have worked out a way to rot the system by using current legislation to victimise those who they disagree with. And the ones who lose out when this sort of fraud is perpetrated by a group that opposes freedom of choice and speech are the Australian taxpayers.

How much does this government persecution cost?

Two months – four investigations. How much have the last three years worth of AVN persecution cost the government? I don't know yet, but I wouldn't think there would be much change out of a couple of million dollars – especially since the HCCC has had to pay their own court costs as well as our own. How much money has the government spent over this period on testing the safety and effectiveness of vaccinations? From what I can tell – absolutely nothing. Perhaps they need a lesson in priorities?

The latest event

Last night, I was contacted by a journalist who informed me that Dr Andrew McDonald, the NSW Shadow Minister for Health, would be calling on the Minister for Gaming and Racing, Mr George Souris, to act to revoke the fundraising license of the Australian Vaccination Network and investigate our operations.

McDonald said our organisation was not a charity (despite being licensed as one since 1996) but a lobby group and it should not be allowed to continue to enjoy the kind of tax breaks that 'real charities' which undertake work for the public enjoy.

This demonstrates the almost unbelievable ignorance of Dr McDonald. Does he really believe that being a charity gives a group tax breaks? Does he not understand the difference between a charity and a deductible gift recipient? Is he completely unaware of the fact that being a charity does not give a group tax breaks – it simply entitles them to do fund-raising and sell raffle tickets?

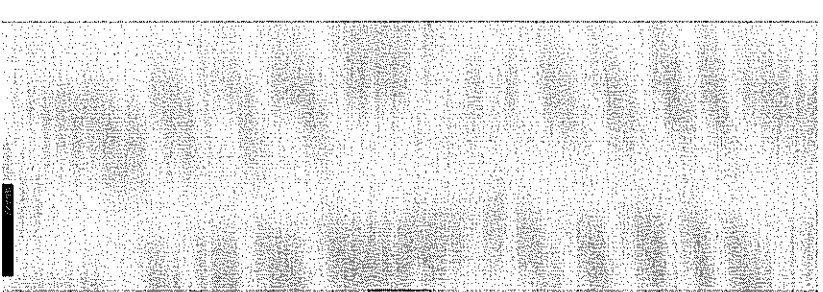
Being a charity can be considered fairly onerous because charities need to be audited at great cost (thousands of dollars a year) and have other strict regulatory requirements whilst other groups that do not 'pursue a charitable purpose' – groups such as the Australian Shepards and Stop the AVN – have none of these requirements and none of this oversight.

We would have gotten rid of the charity authority if we were able to. In fact, we tried before simply because we could not afford it. Unfortunately, the OLSR says that according to our constitution and the work we do, it is obvious that we do indeed 'pursue a charitable purpose' and therefore, we are a 'charity'.

Without the written authority from the OLSR, we would have the worst of both worlds (as we've had for the last 18 months from the time of our revocation to our reinstatement) – the cost of accountability combined with the inability to take on new members (strangely, new memberships are classed as fundraising while renewals and donations from current members are not) or donations from the general public. So we were happy to have our charity authority reinstated – especially with the notification that the only reason it had been revoked was the illegal public warning issued by the HCCC.

Perhaps Dr McDonald might do better to learn a bit about these issues before making public statements about them?

In any case, despite the fact that Dr McDonald has not yet asked his question in Parliament, Mr Souris has issued a response to the journalist who contacted me:



I have been advised by my department that it received legal advice that the revocation of the Australian Vaccination Networks charitable fundraising authority under the former government could not be sustained.

The revocation was based substantially on a public warning issued by the Health Care Complaints Commission (HCCC), however, the Supreme Court has since ruled the Commission's actions invalid.

I have been advised by the Office of Liquor, Gaming and Racing that it has considered a fresh application on its merits from the AVN and that it met all legal requirements for a new charitable fundraising authority.

OLGR has assured me that it will continue to monitor AVN's compliance with charity laws and if breaches are detected appropriate action will be taken.

Any charity committing serious breaches of the law could face revocation of its licence and if this is the case then my department can make a recommendation to me for this to occur.

As I said before, the continued monitoring – the singling out of our organization for no other reason than that we are critical of a medical procedure supported by the government seems to hint at discrimination, persecution and bastardy, but we will do our best to ensure that we strictly adhere to all government requirements. In the meantime, we will deal with all future and present complaints as they arise and keep our membership and the Australian public advised of any new complaints as well in the interest of transparency and fairness.

I sincerely hope that the government will find a way to prevent themselves from continuing to be used by SAVN and the Australian Skeptics as if they were their own personal tools for a vendetta against the vaccine injured children of Australia and their families.

Please take action

If you can include the following information in your letter, that would be great

- 1- The AVN's charity status does not give it any special tax advantages. Those advantages are only available to deductible gift recipients.*
- 2- Even while our charity authority had been revoked, the OLG said that we pursued a charitable purpose. Many charities lobby on behalf of their membership. It's part of what we do and does not preclude our charitable purpose.*
- 3- The NSW government is being used by members of a lobby group whose stated aim is to force our organisation to close in any way they can. They have publicly said that they intend to use these constant complaints to prevent us from doing our job through the time required in responding to issues with government departments. The cost for the assessment, investigation and responses to these vexatious complaints and the ensuing harassment are being borne by the taxpayers of NSW.*

Of course, put in any of your own information as well and be sure to let the Minister and Shadow Minister know if you feel you have been helped in some way by the AVN or if your child has been affected by vaccines.

In July of 2009, Ken McLeod, a member of Stop the AVN and the Australian Skeptics, filed a complaint against both the AVN and its President, Meryl Dorey, with the Health Care Complaints Commission in NSW. Amongst other claims, McLeod said that freedom of speech in Australia was not protected under the law and therefore, the HCCC should use its power to gag both the AVN and Meryl Dorey so that neither the group nor the individual would be allowed to make any statements regarding vaccinations or health. Despite the fact that the HCCC did not have jurisdiction to investigate this claim, what followed was a 2 year witch-hunt which saw the AVN's charity authority withdrawn and the organisation driven to the brink of closure.

In December of 2009, the AVN presented a legal opinion prepared by its lawyer to the HCCC stating that in their opinion, the HCCC did not have jurisdiction to investigate the organisation because the complaint was not a valid complaint under the Health Care Complaints Act. The HCCC

disagreed. Two subsequent written opinions by barristers were also given to show that there was no jurisdiction to investigate the AVN but these complaints were disregarded. It took a Supreme Court case which might have cost the State of NSW several hundred thousands dollars (and did cost the AVN tens of thousands of dollars), to prove that the AVN was correct and that both the investigation and the later actions of the HCCC in ciling the organisation were, in fact, *Ultra vires* or illegal.

In a letter from the Department to the AVN dated June 21, 2012 (Image 3), it was stated that since this blog is located on the AVN's website, they would not be pursuing this issue further.

The Australian Vaccination Network Inc has not included their name anywhere on the publication at <http://australiansceptics.com>. This publication is being promoted on their official Facebook and Twitter accounts, and the domain name australiansceptics.com is registered to "Australian Vaccination Network" there is no doubt that this publication belongs to them.

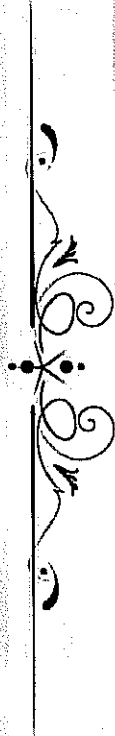

I note your advice that the website <http://australiansceptics.com/> is a blog that appears on the website of the Australian Vaccination Network although it is hosted with wordpress.com.

In light of your advice Fair Trading does not intend to take any further action in relation to this matter.



Back in April of 2012, the AVN received a letter from the Department of Fair Trading in response to a complaint from an unknown party stating that as an incorporated association registered in NSW, we were required to have our full name on all printed matter and that included our website which, at that point in time, said AVN, Inc. – Not Australian Vaccination Network, Inc.

We were completely unaware of this requirement but since our website was being redesigned at that time (including the logo), we simply changed the details to suit the Department.

When we wrote a letter to the Department informing them that the website had been changed, we also informed them that as a test, we looked up the websites of 15 random incorporated associations registered in NSW (we selected them by searching their database for incorporated associations and several of these are very large and well-funded groups) and out of those 15, 14 of them did not have their full name and the word 'inc.' or 'incorporated' on their page or pages, it seemed to us that since it is apparently common for associations not to have this information on their website, we had once again been singled out for 'special treatment' from a government department.

Below is the response I received from the Department on the 19 of April, 2012 in regards to this issue:

The information in relation to the amendment to the Association's banner on its website and signage on its shop to include the initials 'inc' is noted with thanks.

Your comments in relation to other incorporated associations' failure to correctly identify themselves are also noted. NSW Fair Trading takes action in relation to issues arising from breaches of the Act, of this type, where instances come to our attention. In such cases, Fair Trading reminds associations of this obligation and generally associations take the necessary remedial actions to comply as the Association has on this occasion. Certainly Fair Trading has not found it necessary to prosecute an association for this type of breach to date.

Yesterday the Police came to my door to deliver a summons for court in NSW. The summons, delivered on the 25th is for a court hearing on the 27th. That's 48 hours in which to prepare a defence and travel to the other side of the country. Prior to this I had no idea what the grounds for the application were. Needless to say I won't be in court for the mention, but I will certainly attend the later hearing which is when the real action takes place. 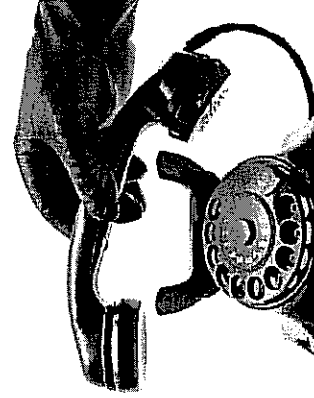
Today's story is one of horror. It will be VERY DISTURBING to most of my readers. For, even as never before, with this example, it graphically identifies the core values of the quackbuster/skeptics. It depicts who they really are.

I apologize, in advance, for what you are about to read, but someone must expose this situation. No matter how uncomfortable the information we need to see, for ourselves, exactly what we are dealing with, so we can make decisions on how to proceed.

So, let's proceed.

Ms Dorey traced the phone number from which these calls originated. Her trace indicated that they had come from the home of a person who is a manager of the Stop the AVN Facebook page. The police have done a thorough investigation of this information and have – as of September 28th, 2012, officially confirmed that the calls did indeed originate from this person's home.

(1) The first photo is of a black man raping a dead white woman whose body has already been torn in half. The message to the AVN, from the sender, is very clear, especially when taken into context with the following two messages:

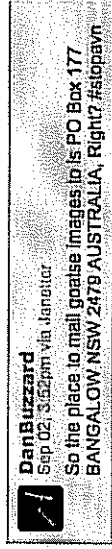

I suspect that Buzzard, clearly a Skeptic, picked this imagery due to familiarity. This activity might well be a featured event, shared by the members, at every "skeptic" meeting. In fact, it may well be the primary activity.

(3) The third photo is of three older men engaging in homosexual sex. Meryl Dorey says of this: *"The same person who sent me the email message also posted the following onto the AVN's facebook page."*

I suspect, as before, that the skeptics are using imagery, in their hate campaign, familiar to their life style.

(4) The fourth photo is part of an anonymous letter sent to Meryl Dorey in the Australian mail.

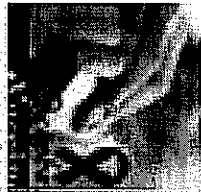

"These attempts to shut down the AVN have included investigations and warnings issued by the Health Care Complaints Commission (HCCC) which we had to fight long and hard to finally defeat. We accomplished this in the Supreme Court which determined that the HCCC acted illegally when conducting their investigation and issuing a warning against us..

They tried to close us down by using the Department of Fair Trading - several times. They tried with ASIC when we weren't even registered with ASIC.
